DEDICATED.

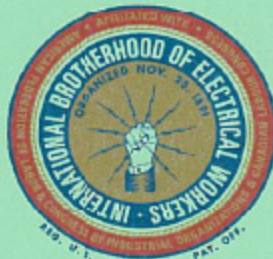
